#### Clarification Items:

1. The furniture scope and package are to be Vendor Furnished, Vendor Installed. Please refer to the plans for all Contractor Installed items.

#### **Questions:**

- 1. Does the front window (f) with the slope top need to be covered. If so, does just the bottom rectangle portion need a shade?
  - a. There is no WS-1 window shade at this window.
- 2. I could not find page 1d. 1.0 (should have shade location) If not, I can use the exterior elevation if all exterior windows need to be covered.
  - a. Refer to ID1.1. All window shades are keynoted.
- 3. Would an alternative manufacture be acceptable? We manufacture roller shades in our local factory and can use the spec'd material E screen pearl/ linen 3%.
  - a. We will entertain alternate manufacturers that meet the same performance as the basis of design. Please submit a substitution request with product comparison for review and approval.
- 4. The specs aren't very specific in regards to strength/thickness of the flagpole, but per the specs: You can range from the thinnest (5" butt, 3" top, .125" wall thickness: \$3995) to the thickest option (6", 3.5" .188": \$5995), with other options in between.
  - a. Utilize the 6" butt, 3.5"top, .188" wall thickness option.
- 5. Control space on the side of the elevator shaft. This went out for bid late last year and I did not bid on it due to the basis of design. If we can get approval for there to be a man door on the side of the shaft to house our controller and give access to the pump unit and an 8'-2" wide x 5' - 10" deep shaft, we will be able to supply a bid.
  - a. Please submit a formal substitution request with product data for review.




