MONDAY, JUNE 25, 2018**

**ORDINANCE #5-21-18A -2<sup>nd</sup> Reading- 2018-2019 Fiscal Yr. Budget** – A motion was made by Kelly Kramer, seconded by Mardy Sidebottom, to have City Attorney, John Singler give a second reading by summary of Ordinance #5-21-18A. Motion carried unanimously and Mr. Singler gave a second reading. A motion was made by Becky Ricketts, seconded by Mardy Sidebottom, to adopt Ordinance #5-21-18A. Upon roll call vote the following vote “aye”: Dustin Gilchrist, Betsy Kramer, Kelly Kramer, Carla Nalley, Cami Popham, Becky Ricketts and Mardy Sidebottom. No one voted “nay”. Motion carried unanimously.

Motion carried unanimously and Mr. Singler gave a second reading. A motion was made by Becky Ricketts, seconded by Kelly Kramer, to adopt Ordinance #5-21-18B. **MUNICIPAL ORDER #6-25-18- Case No. 18DEVPLAN1032- Revised Development Plan for 703 Lyndon Lane-** Nick Pregliasco answered questions from council along with Kevin Young and Grady Stewart. Discussion was held. A motion was made by Betsy Kramer, seconded by Carla Nalley to approve the revised development plan for Case No. 18DEVPLAN1032. Motion carried unanimously.

**MUNICIPAL ORDER #6-25-18A- 1-year extension option to garbage contract-** A motion was made by Becky Ricketts, seconded by Cami Popham to approve the rates on a 1-year contract with Rumpke. Discussion was held on future bidding contracts. Motion carried unanimously.

Mayor Hagan introduced the City's new contracted code enforcement officer, George Stewart. Last month'

s report was provided and Mr. Stewart answered a few questions, gave descriptions on certain violations he is dealing with and took suggestions. Discussion was held. The Mayor stated the City is getting results from the increase in enforcement and Mr. Stewart is doing a great job. Mardy Sidebottom noted that residents are taking notice of the positive changes.
