

**CITY OF LYNDON  
COUNCIL MEETING MINUTES  
MONDAY, JANUARY 28, 2019**

Mayor Brent Hagan called the Council Meeting to order at 6:00 p.m. The Pledge of Allegiance was recited. Those present: Susan Barto, Betsy Kramer, Kelly Kramer, Becky Ricketts, Mardy Sidebottom, Amy Stuber and Attorney, Carrie Ritsert for John Singler. Guests were also present.

A motion was made by Kelly Kramer, seconded by Susan Barto to approve the minutes of the December 17, 2018 Council Meeting. Motion carried unanimously. A motion was made by Becky Ricketts, seconded by Mardy Sidebottom to approve the minutes of the January 21, 2019 Caucus Meeting. Motion carried unanimously.

The Treasurer's Report was given and will be filed for audit. Balance for January 1, 2019 was \$3,173,266.70

**ORDINANCE #12-17-18B – 2<sup>nd</sup> Reading – Accepting Public Dedication of Eagle Creek Roads** - Motion made by Becky Ricketts, seconded by Mardy Sidebottom to have have Attorney, Carrie Ritsert give a second reading by summary of Ordinance #12-17-18B. Ms. Ritsert gave a second reading. A motion was made by Becky Ricketts, seconded by Amy Stuber to approve Ordinance #12-17-18B. Upon roll call vote, the following voted “aye”: Susan Barto, Betsy Kramer, Kelly Kramer, Becky Ricketts, Mardy Sidebottom and Amy Stuber. Motion carried unanimously.

The Mayor reminded council about KLC's City Day/Night on February 13<sup>th</sup> for those who want to attend. The next Caucus Meeting will be February 18, 2019 at 6:00 pm and the next Council Meeting will be February 25, 2019 at 6:00pm.

There was no further business from the council.

**OPEN FLOOR:**

Mayor Hagan announced a policy that will be in affect from now on regarding open floor speaking and conduct. Those who signed in an wished to speak were called on. Mr. Charles Knopf from Eagle Creek asked since the city approved the road dedication and are now in charge of maintenance, would it be acceptable for the HOA to take care of salting the bridge. The Mayor permitted them to do so. Mr. Knopf mentioned two other issues that need to be addressed: lighting at post office entrance and a tree limb on Ormsby Lane that still has caution tape around it from when it was cut from the road.

Donald Dunn, Grant Ave, was told he had 2 minutes to speak. He approached a council member, waving a sheet of paper at them asking if “this was still effective”. The Mayor asked Mr. Dunn to direct the question to him and took the sheet. Mr. Dunn was speaking of Municipal Order #2-23-09 which was in effect and has been discussed with him in the past. Mr. Dunn stated 6 Bob Ray Company trucks are using his street. The Mayor stated the municipal order allows Bob Ray trucks up to 12 trips on Grant Ave. Mr. Dunn said they have been down more than 12 times before. The Mayor asked Mr. Dunn to present proof in the future. Mr. Dunn also accused the city of not ever plowing snow on his street. The Mayor stated he knew for a fact his street has been

plowed. Mr. Dunn refuted the comment and went on to other topics saying his street needed more streetlights and a sidewalk. Mayor Hagan explained the city requires petitions for both requests to be reviewed. Mr. Dunn turned to leave still talking out of order and made an inappropriate comment to the Graymoor-Devondale police officer who followed him out.
