## CITY OF LYNDON COUNCIL MEETING MINUTES MONDAY, MARCH 27, 2023

In the absence of Mayor Hagan, City Attorney John Singler asked for a motion which was made by Amy Stuber, seconded by Betsy Kramer, to appoint Susan Barto as Mayor Pro-tem. The Pledge of Allegiance was recited. Those present: Susan Barto, Betsy Kramer, Carla Nalley, Mardy Sidebottom, Vicki Stanley, Amy Stuber and City Attorney, John Singler. Becky Ricketts was absent. Guests were present.

A motion was made by Amy Stuber, seconded by Carla Nalley to approve the minutes of the February 27, 2023 Council Meeting. Motion carried unanimously. Amy Stuber made one correction to the March 20, 2023 Caucus Minutes. A motion was made by Betsy Kramer, seconded by Vicki Stanley to approve the March 20, 2023 minutes with the correction. Motion carried unanimously.

The Treasurer's Report was given and will be filed for audit. Ending balance for March 1, 2023 was \$4,496,175.55.

ORDINANCE #2-27-23A – 2<sup>nd</sup> Reading – Amending and Adding Short-Term Rental to the Lyndon Land Development Code - A motion was made by Carla Nalley, seconded by Betsy Kramer to have City Attorney John Singler to give a second reading by summary of Ordinance 2-27-23A. Motion carried and Mr. Singler gave a second reading. He also stated there was discussion from the Caucus Meeting to add a penalty section to the ordinance. **OPEN FLOOR:** Laura Austin, Lyndon resident, introduced an idea for a community project involving a collection of plastic bottle caps made into benches by GreenTree Plastics in Indiana. She emailed the City regarding the details which have been passed on to each council member if they are interested in arranging such project. It would involve promoting the need of donations, sites to collect caps, location to store large collections, identifying someone to deliver the bags of caps and bringing back a bench. Discussion was held.
